**Sub.: Admission of students in the 1st year of Diploma Course in Pharmacy for the Academic Session 2025-26 in Self-Financed / Private Institutions under (1) Management Quota Seats and (2) Remaining Vacant Seats of Counselling Quota after completion of 2<sup>nd</sup> Phase Counselling**

Sir / Madam,

You are aware that the online counselling for admission of students in the 1st year of Diploma Course in Pharmacy for the Academic Session 2025-26 has been conducted in two phases. After completion of the online counselling, it has been observed that some seats are lying vacant in several self-financed institutions under Counselling Quota.

In the aforesaid circumstances, it is hereby informed that the self-financed institutions may take admission of eligible students in the remaining vacant seats under Counselling Quota. The details of such students are required to be entered through the portal <https://sctedved.wb.gov.in/polyadm/>. A caption named “**Direct Admission**” will be activated for the said purpose under College Login.

Apart from the aforesaid, another tab named “**Management Quota Admission**” will also be present in the college login through which the details of the students who have been admitted in your institution under Management Quota.

Please note that, the admission of all students in Self-Financed Institutes under Management Quota as well as the remaining vacant seats under Counselling Quota, shall have to be made through the above portal. **The last date of entering the details of the students for both the aforesaid cases is 13.02.2026.**
